Mayor Winarski led the Pledge of Allegiance and the Invocation was given by Pastor Andrew Dear.

Public Hearing:

Motion by Council Member Mienk, supported by Council Member Crawford to open the Public Hearing for the Recreation Plan. All ayes. Motion carried. George Alward is in great support of the Recreation Plan. Dan Svetcos thinks it is a great idea.

Hearing of Delegations

Officer Eric Killian – Chief Duane Bean recently attended a conference in which the use of body cameras was a topic of discussion. The Police Department purchased one camera at a cost of \$100 for testing. Officer Killian has tried it out and it works really well in the day time but the current camera does not offer high enough resolution for at night. Officer Hale used it at a call at the hospital with a disorderly person. The Police Department is able to download video at the office to confirm what had happened. Two more low resolution cameras and a high resolution camera for at night were ordered.

George Alward – Chief of the Gladwin Rural Urban Fire District – Explained how the fire district is run, what equipment they have, and that there are 38 firefighters in the district,

the equipment they need and training they must have. He talked about the challenges of meeting the National Fire Protection Association mandates. He stated the Fire district falls under an insurance rating of 5. The district has automatic mutual aid agreements with surrounding districts. He also stated that the district deals with 230 to 250 incidents every year. And the response time averages is 2.5 minutes.

Mayor Winarski presented a Mayoral Proclamation to George Alward.

PERFORMANCE RESOLUTION FOR GOVERNMENTAL AGENCIES

Page 1 of 2

This Performance Resolution is required by the Michigan Department of Transportation for purposes of issuing to a municipality an "Individual Permit for Use of State Highway Right of Way" or an "Annual Application and Permit for Miscellaneous Operations Within State Highway Right of Way".

RESOLVED WHEREAS, the CITY OF GLADWIN	
(city, village, township, etc.)	

hereinafter referred to as the "GOVERNMENTAL AGENCY," periodically applies to the Michigan Department of Transportation, hereinafter referred to as the "DEPARTMENT," for permits, referred to as "PERMIT," to construct, operate, use and/or maintain utility or other facilities, or to conduct other activities, on, over, and under State Highway right of way at various locations within and adjacent to its corporate limits;

NOW THEREFORE, in consideration of the DEPARTMENT granting such PERMIT, the GOVERNMENTAL AGENCY agrees that:

- Each party to this Agreement shall remain responsible for any claims arising out of their own acts and/or omissions during the performance of this Agreement, as provided by law. This Agreement is not intended to increase either party's liability for, or immunity from, tort claims, nor shall it be interpreted, as giving either party hereto a right of indemnification, either by Agreement or at law, for claims arising out of the performance of this Agreement.
- Any work performed for the GOVERNMENTAL AGENCY by a contractor or subcontractor will be solely as
 a contractor for the GOVERNMENTAL AGENCY and not as a contractor or agent of the
 DEPARTMENT. The DEPARTMENT shall not be subject to any obligations or liabilities by vendors and
 contractors of the GOVERNMENTAL AGENCY, or their subcontractors or any other person not a party
 to the PERMIT without its specific prior written consent and notwithstanding the issuance of the
 PERMIT. Any claims by any contractor or subcontractor will be the sole responsibility of the
 GOVERNMENTAL AGENCY.
- 3. The GOVERNMENTAL AGENCY shall take no unlawful action or conduct, which arises either directly or indirectly out of its obligations, responsibilities, and duties under the PERMIT which results in claims being asserted against or judgment being imposed against the State of Michigan, the Michigan Transportation Commission, the DEPARTMENT, and all officers, agents and employees thereof and those contracting governmental bodies performing permit activities for the DEPARTMENT and all officers, agents, and employees thereof, pursuant to a maintenance contract. In the event that the same occurs, for the purposes of the PERMIT, it will be considered as a breach of the PERMIT thereby giving the State of Michigan, the DEPARTMENT, and/or the Michigan Transportation Commission a right to seek and obtain any necessary relief or remedy, including, but not by way of limitation, a judgment for money damages.
- 4. The GOVERNMENTAL AGENCY It will, by its own volition and/or request by the DEPARTMENT, promptly restore and/or correct physical or operating damages to any State Highway Right of Way resulting from the installation construction, operation and/or maintenance of the GOVERNMENTAL AGENCY'S facilities according to a PERMIT issued by the DEPARTMENT.
- 5. With respect to any activities authorized by PERMIT, when the GOVERNMENTAL AGENCY requires insurance on its own or its contractor's behalf it shall also require that such policy include as named insured the State of Michigan, the Transportation Commission, the DEPARTMENT, and all officers, agents, and employees thereof and those governmental bodies performing permit activities for the DEPARTMENT and all officers, agents, and employees thereof, pursuant to a maintenance contract.

The incorporation by the DEPARTMENT of this resolution as part of a PERMIT does not prevent he DEPARTMENT from requiring additional performance security or insurance before issuance of a PERMIT.

7. This resolution shall continue in force from this date until cancelled by the GOVERNMENTAL AGENCY or the DEPARTMENT with no less than thirty (30) days prior written notice to the other party. It will not be cancelled or otherwise terminated by the GOVERNMENTAL AGENCY with regard to any PERMIT which has already been issued or activity which has already been undertaken.

BE IT FURTHER RESOLVED, that the following position(s) are authorized to apply to the DEPARTMENT for the necessary permit to work within State Highway Right of Way on behalf of the GOVERNMENTAL AGENCY.
