ORDINANCE #325 AMENDMENT TO THE GLADWIN CITY ORDINANCE 237 (Section 35.25, et seq, of the Gladwin City Code of Ordinances)

An Ordinance to amend Gladwin City Ordinance 237, enacted on November 16, 1998, being Section 35.25, *et seq*, of the Gladwin City Code of Ordinances, and entitled "Tax Exemption for Village North Apartments as Provided by State Housing Development Act."

1. <u>Section 35.29</u> **ESTABLISHMENT OF ANNUAL SERVICE CHARGE** shall be amended to provide as follows:

The housing development identified as Village North Apartments and the property on which it shall be constructed shall be exempt from all property taxes from and after the year the project is placed in service as evidenced by a certificate of occupancy from the appropriate public officials. The City acknowledges that the sponsor and the authority have established the economic feasibility of the housing development in reliance upon the enactment and continuing effect of this subchapter and the qualification of the housing development for exemption from all property taxes and a payment in lieu of taxes as established in this chapter, and in consideration of the sponsor's offer, subject to receipt of an allocation under the LIHTC program, to construct, own and operate the housing development, agrees to accept payment of an annual service charge for public services in lieu of all property taxes. The annual service charge shall be equal to eight (8%) percent of the annual shelter rents actually collected through the calendar year 2013, and nine (9%) percent of the annual shelter rents actually collected for any year subsequent to 2014.

2. **Section 35.33 DURATION** shall be amended to provide as follows:

This subchapter shall remain in effect for a period of thirty (30) years after the certificate of occupancy is obtained from the appropriate officials, so long as the Housing Development remains subject to income and rent restrictions pursuant to Section 42 of the Internal Revenue Code of 1986, as amended, provided however, that Village North Apartments shall not be entitled to a service charge in lieu of property taxes for the calendar year 2014, being the year in which this Amendment was enacted.

3. Except as amended in this Ordinance, the remaining provisions of Sections 35.25 to 35.35, inclusive, of the Gladwin City Code of Ordinances are continued.

This Ordinance was offered by Council Member Rowley, second by Council Member Caffrey, for 1st Reading on March 17, 2014 and 2nd Reading on April 7, 2014.
